

## **Regional Trade, Growth and Emergency Response: Strategic Options for Dealing with Recurrent Food Crises in Southern Africa**

Southern Africa is in the grips of another food crisis. Poor weather has ignited this crisis but structural causes underlie it. Researchers from MSU's Food Security III Cooperative Agreement have been working with national and regional partners to identify how regional trade, government policies, and food assistance can be structured to protect vulnerable groups' access to food during transitory crises while promoting long-term income and productivity growth. Drawing also from recent experience in West Africa, MSU's analysis provides guidance on how regional trade, food assistance and long-term investments and policies can be more successful and less costly in meeting short-term crises -- like the one emerging in Southern Africa -- while also strengthening the region's ability to withstand recurrent droughts in the future.

AFR/SD and EGAT/AG are sponsoring a roundtable discussion to highlight lessons learned on how markets can be used and further developed to meet the needs of the poor in the face of persistent food shortages. We will also explore strategic options for moving forward including the potential and limitations of trade, local food procurement, alternative safety net programs, market information systems, and government marketing policy, with implications for on-going policy processes in the Southern Africa region.

The round table discussion will involve David Tschirley, John Staatz, Michael Weber, Duncan Boughton, and Thom Jayne from Michigan State University. Arrangements are also being made to involve experts on the food situation in Southern Africa from other organizations, including FEWS, the World Bank, IFPRI, and various units within USAID.
